Companies that transport goods across borders or between customs warehouses must declare the transit according to customs law with the relevant customs authorities. In the trade zones of the European Union (EU), the European Free Trade Association (EFTA) and Turkey and Serbia, transit declarations must be submitted in the computerised transit system (NCTS). The NCTS is an IT system via which the customs authorities of the participating countries exchange data electronically. In the Russian and Belarussian Customs Union, a similar system exists. This IT-supported transit service moves the required import checks away from borders, and speeds up the declaration process.

TransitNet is your direct access to the NCTS environment. This web based single window system enables you to declare transit procedures to customs authorities inside and outside the EU (including Belarus) with just the one tool.
