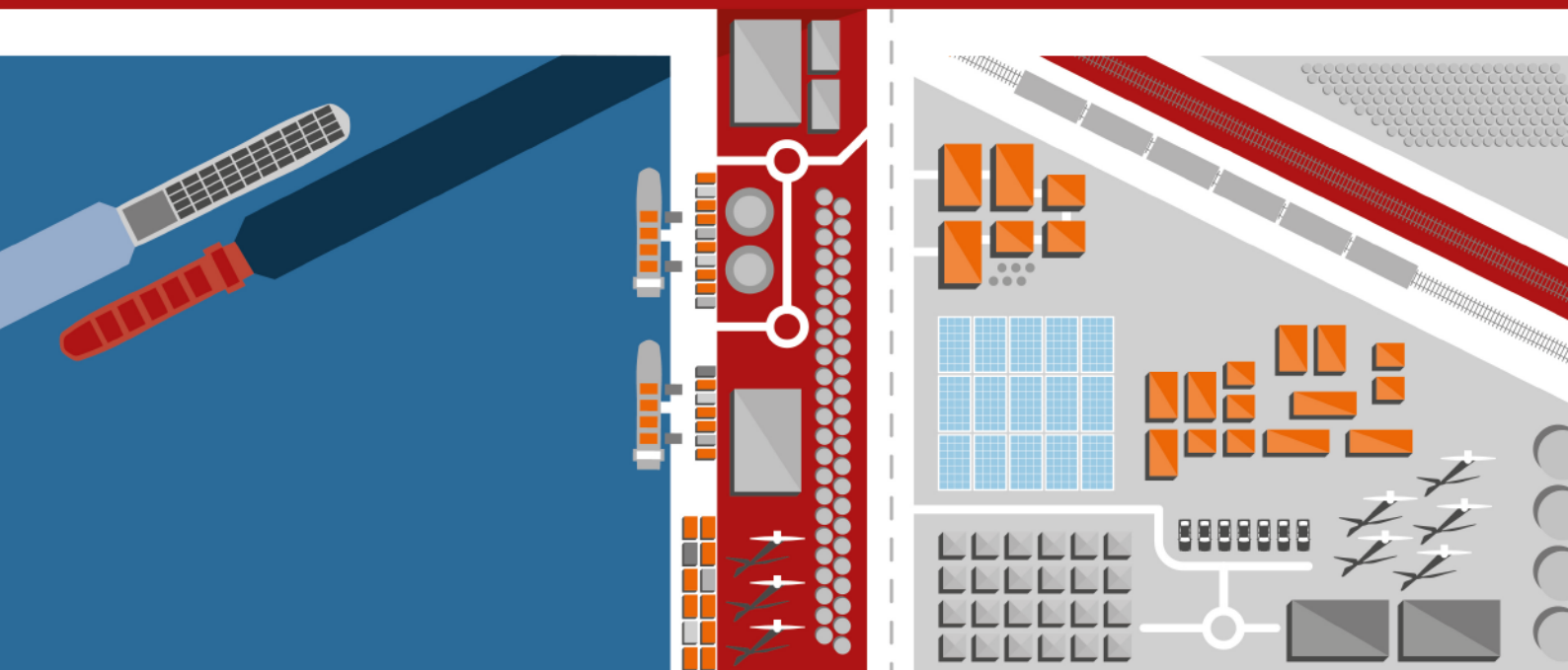

UK to EU checklist

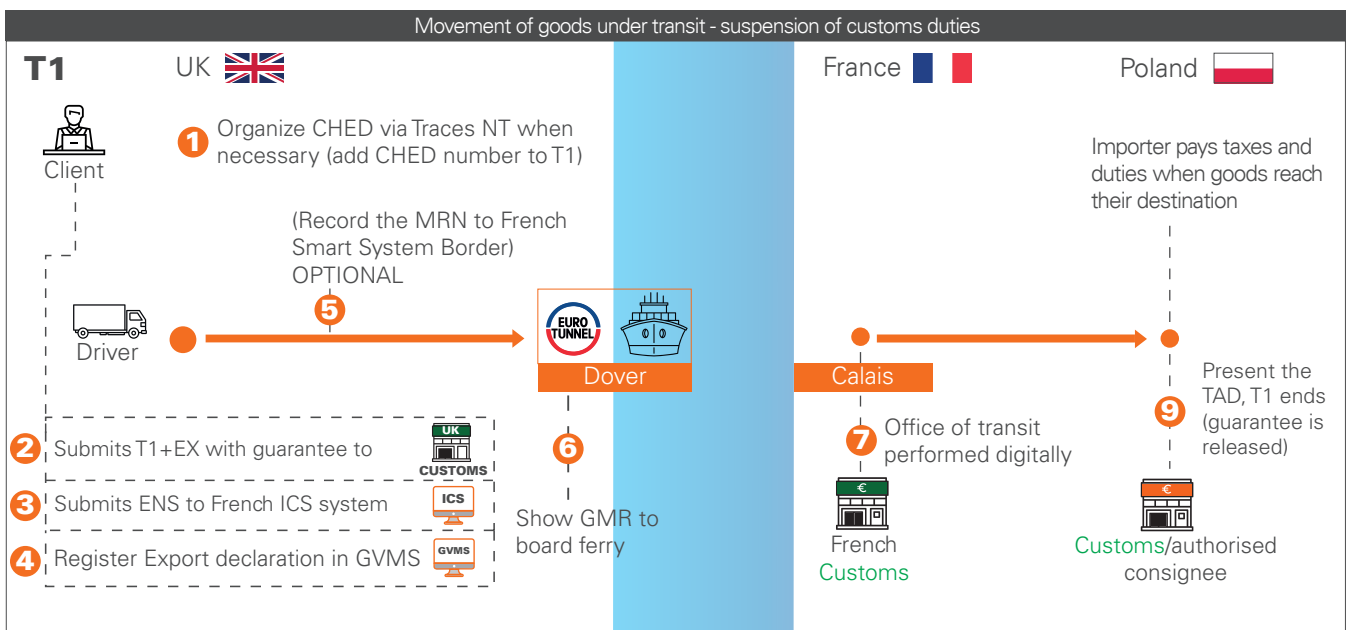
In January 2021, the UK became what is known as in customs terms, a 'third country'. As a result, any goods UK to EU and vice versa require Customs Declarations.

Transit is a customs procedure which moves the import clearance of the goods away from the entry point of the EU to an inland location closer to the destination of the goods.

To submit a Transit Declaration, companies need a comprehensive customs guarantee along with customs-adapted software. These can be difficult and expensive to obtain and maintain. 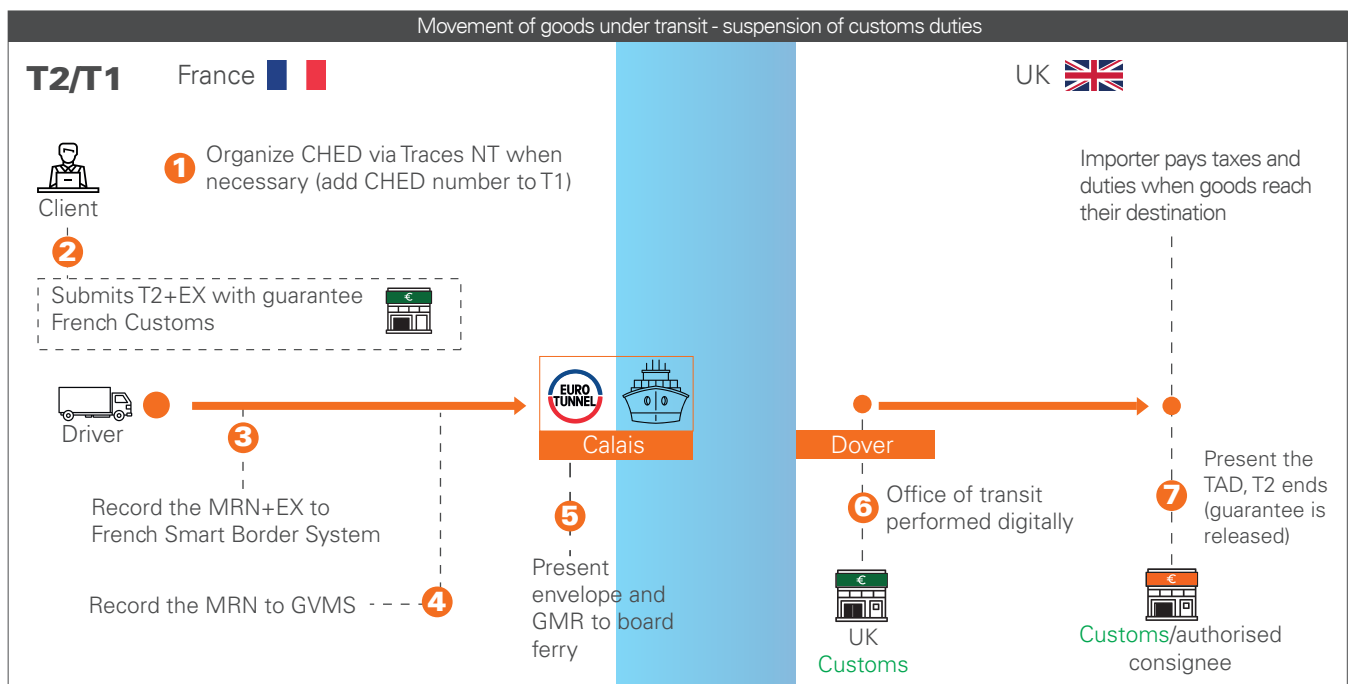


EU to UK checklist

Transit can also be used for shipments between the EU and the UK. Using transit will remove the necessity for importers to pre lodge full import declarations before the goods have even arrived in the UK. Under transit, the clearance of the goods can be completed, including the import procedure and payment of any relevant tax and duties, at a location closer to the actual destination of the goods. Transit is an efficient way for goods to be moved through ports and it reduces the possibilities of control thus saving companies time and money.
