SGS TransitNet

TransitNet is a secure, multilingual, web-based platform that captures, controls and monitors transit declarations, allowing all users to track them online until termination.

TransitNet is a universal, multimodal e-customs transit guarantee service where we act as the holder of the procedure (HoP) towards customs on behalf of our clients (transporter, broker, freight forwarder, etc.). This enables clients to create transit declarations and submit them, along with a financial guarantee in favor of customs, to any customs system where we act as HoP.

TransitNet is connected to multiple customs systems, including NCTS connections in countries such as the United Kingdom, Turkey, Switzerland and Romania.

TransitNet – simplifying the process for clients

- **No need to be a customs expert** – after a short training session, users will have sufficient knowledge to create and submit transit declarations independently
- **Free to use** – no subscription fees are required to access the TransitNet web-based application
- **Unlimited users** – no additional cost per user, multiple company representatives can work simultaneously
- **Paperless, in real-time** – fully dematerialized system allowing online tracking of all transit declarations with real-time updates


